# 1.THE PRE-QUALIFICATION

## 1.1 Introduction

The Kenya Railway Golf Club (KRGC) was established in the year 1921 under the society's rules, 1968 (Rule 4), and is strategically located in the Nairobi Central Business District. The club consists of a cosmopolitan, corporate and entrepreneurial membership covering various government and private sector decision-makers. Being the only 9-hole par 72 course with an active Railway line passing through the course, the club attracts over 2000 local and international guests and golfers throughout the year.

**KENYA RAILWAY GOLF CLUB** here after, "KRGC" invites applications from interested supplier for prequalification for supply and delivery of various categories of items for the period July 2025 – June 2027. The terms for supply are provided in this document.

## 1.2 Pre-qualification Objective

The main objective of the pre-qualification process is to identify potential suppliers of goods and services to the Club for the period stipulated above. Therefore, the Club invites established suppliers with capacity to provide quality goods and services within the terms and conditions specified in this document.

Bidders are required to submit their bids for the category of items that they have capacity and experience in. Therefore, bidders requested to submit bid documents clearly indicating the category and items that they intend to supply to the Club for the duration stipulated in this document. Existing suppliers who wish to be retained must also re-apply and submit information requested in the pre-qualification document.

Bid documents will be opened immediately after the closing date and time in the presence of bidders or their appointed representatives. Appointed representatives will be required to submit their letters of appointment and fill-in their details in a Pre-Qualification Bid Opening Register.

### **3.0 PRE-QUALIFICATION REQUIREMENTS**

Potential suppliers are required to abide by the following requirements;

#### **3.1 Taxes on Imported Materials**

The Supplier will be responsible for payment of all taxes payable as applicable for all imported materials to be supplied.

#### **3.2 Customs Clearance**

The contractors shall be responsible for custom clearance of their imported materials.

#### **3.3 Contract Price**

The contract shall be based on unit price type or cumulative of computed unit price and quantities required. Prices quoted must be inclusive of all delivery charges and taxes.

#### **3.4 Payments**

All local purchases shall be on credit of a minimum of thirty (30) days or as may be stipulated in the negotiated Contract Agreement.

#### **3.5 Quality of goods, Services and workmanship**

The Club expects supply of quality goods, services and workmanship and on a timely basis. Potential suppliers are required to exercise due care when making supplies to the Club and in particular observe high level of hygiene standards for food items.

Bidders are notified that sub-standard goods/services and/or workmanship shall not be accepted. The entire cost for supply of substandard goods/services and/or workmanship will be borne by the supplier.

## **4.0 INSTRUCTIONS TO SUPPLIERS**

- I. This application form must be completed in full, incomplete submissions will not be processed.**
- II. All the required and supporting documentations must be submitted jointly with the Form.**
- III. Failure to submit supporting and requested information will lead to your company not being registered.**
- IV. Bidders can only participate up to a maximum of two (2) categories.**
- V. The Checklist for Club Officials section on page 11 is not to be completed by Suppliers.**
- VI. Confidential Business questionnaire section on page 12 is a pre-requisite for registration and therefore must be completed in full. Failure to complete this section will lead to your business not being registered.**
- VII. Potential Suppliers providing professional consultancy services, maintenance & support services or any other technical service are required to submit a schedule of the staff expected to be involved in the provision of services to the Club. The schedule should contain at the minimum the following; Full Name, designation, qualifications (Academic & Professional), day contact and email address using Form PQ-7. In addition, submit signed CV of the key personnel to using the format provided in Form PQ-8. Those not offering those services should not fill out form PQ-5 Section b, PQ-7 and PQ-8.**
- VIII. It is compulsory to complete Categories and List of Items section on page(four) 4. Please be specific in terms of products and/or services that your firm can supply to the Club. Please tick in the appropriate box. This section will enable the Club to afford your company an opportunity to submit quotations or tenders whenever the opportunities arise.**
